## **Summary of Continuous Improvement Efforts since Last Report**

Respond here: The CJ program is actively reviewing course rotations to ensure timely graduation for students. A key focus of the student learning outcomes is on prioritizing social responsibilities. Notably, the course CRIJ 4311 Ethical Issues achieved a perfect passing rate in both the main assignment and final class grade. To enhance student success, the instructor has increased class discussions, resulting in noticeable improvements. However, the course CRIJ 4310 Social Justice, which contributes to the examination of the SLO goals, was not offered during the 22-23 academic year due to the faculty shortage. Fortunately, it will be available in Fall 2023, taught by a newly hired faculty member. Moving forward, regular offerings of this course are anticipated.

Instructors have revised major assignments to enhance the SLOs related to critical thinking and analytical planning/skills. For instance, in the course CRIJ 4380 Research Method, students successfully applied their acquired knowledge and techniques in a faculty-led research project. This experience proved to be beneficial for students. Additionally, in CRIJ 3311, the class incorporates debates or presentations alongside the final paper to evaluate students' abilities in addressing theoretical interpretations and applications. CRIJ 4321 courses are introducing new assignments to further expand upon the analytical skills students acquired in CRIJ 3311. Collectively, these additional assignments offer valuable data for assessing the SLOs in critical thinking and analytical planning/skills. Lastly, the final SLO goal, which involves integrating knowledge from various social sciences and humanities disciplines to comprehend policy implications, has seen improvements due to higher performance in major assignments and increased course passing rates.

## **Program Highlights Since Last Report**
