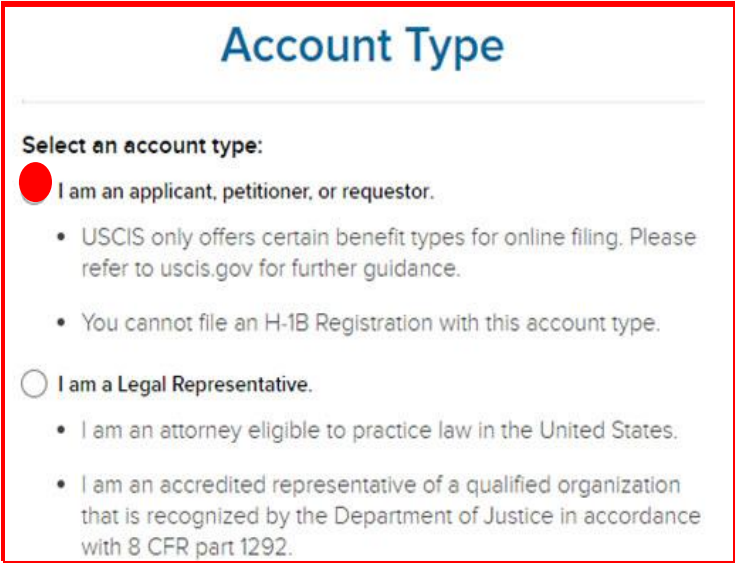
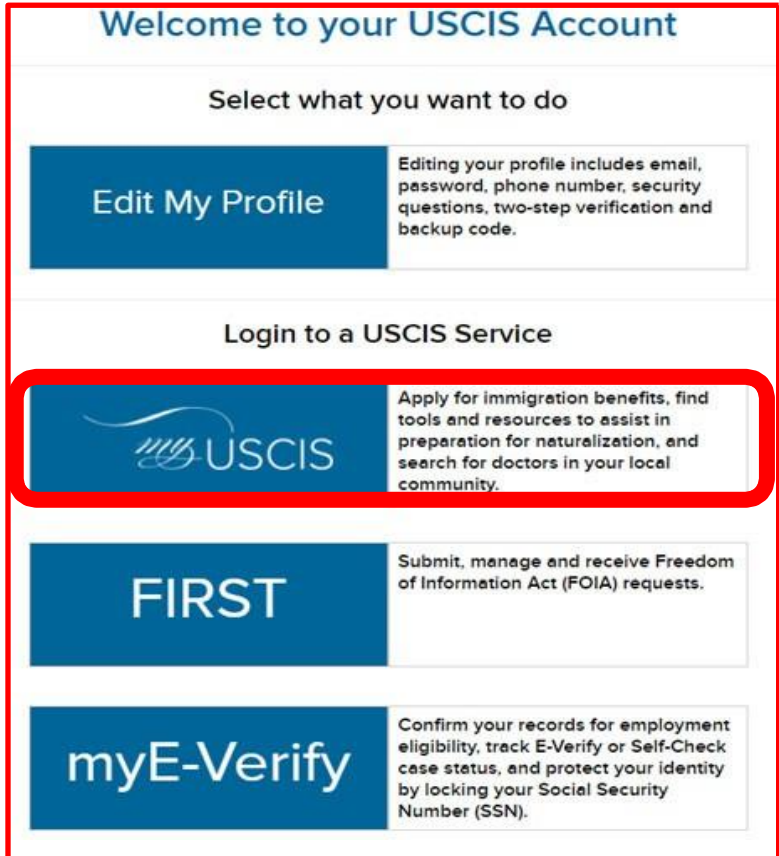


Do not proceed to the final submission of an online I-765 application until:

- You have reviewed the directions below and those in the online I-765
- You have uploaded into the LU OIES “OPT 12 Month Request” the draft I-765 PDF from the OIES guides and forms section of the International Education and Services webpage.
- You have received a newly updated OPT I-20 through the LU OIES process and uploaded a signed scan of it into the “Form I-20” page of the “Evidence” section of the online I-765.

File the Online I-765 for OPT

Go to [How to Create a USCIS Online Account](https://www.uscis.gov/i-765) for a preview of the account setup process. Then go to <https://www.uscis.gov/i-765> and scroll down to the blue “File Online” link to set up an initial USCIS online account. The directions below address some basic items in the online I-765 process. For further questions make an appointment with an OIES staff member for in person advising through the appointment section of the OIES webpage subheading International Student Programs and Services.

File a Form

Select the form you want to file online. Once you start, we will automatically save your information for 30 days, or from the last time you worked on the form.

Concurrent filing available

Select the form you want to file online.

- I-90, Application to Replace Permanent Resident Card
- I-130, Petition for Alien Relative
- I-539, Application To Extend/Change Nonimmigrant Status
- I-765, Application for Employment Authorization

Use this form to request employment authorization and an Employment Authorization Document (EAD) if your immigration status allows you to work in the United States.

Note: You may submit Form I-765 online only if your eligibility category is:

- (c)(3)(A) - F-1 student, pre-completion OPT;
- (c)(3)(B) - F-1 student, post-completion OPT;
- (c)(3)(C) - F-1 student, 24-month extension for STEM students (students holding a degree in science, technology, engineering, or mathematics);
- (a)(12) - Temporary Protected Status (You are submitting an initial Form I-821 or you have an approved Form I-821); or
- (c)(19) - Temporary Protected Status (You have a pending Form I-821.)

All other applicants must submit a paper [Form I-765](#).

- I-821, Application for Temporary Protected Status (TPS)
- N-336, Request for a Hearing on a Decision in Naturalization

Much of this page is self-explanatory. However, the mailing address you list must be able to receive mail in your name up until your EAD is approved. Attempting to change a mailing address for a submitted and pending application is problematic. If you anticipate moving in the months following the application, then we recommend you list the name of a trusted friend in the "In Care Of" field whose address you know will remain valid and monitored.

Remember that government mail does not forward, so if you arrange with USPS to have your mail forwarded to a new address, your EAD card will be automatically returned to the government. Speak to an OIES staff member if you have questions about this.

If the mailing address above is different from where you reside physically, then you should answer "No" and be sure to list your actual physical residence at the time of submitting this application.

A scanned printout or digital picture/screenshot of just the I-94 page (not the Travel history) of this site will need to be uploaded in the later "Evidence" section of the online I-765 form. Make a screenshot or printout of the I-94 page when looking up your I-94 information.

Most F-1 students will not have an A-Number, so this may be left blank if they do not apply to you. If you previously were authorized for OPT, the A-Number appears after "USCIS#" on the past EAD card, and those digits can be entered on the field to the left.


Most students similarly will not have a USCIS Online Account Number; therefore, the box can be checked, and the field is left blank.

If you answer YES, a field will open where you can list your SSN.

If you do not already have an SSN and would like to receive one to have it ready to show a future OPT employer, then click YES and complete the fields that appear.

If you applied in the past for OPT after a previous degree and received an EAD card, upload a scan of that expired OPT EAD here.

If you had any CPTs during your current degree, an OIES staff member can give you a screenshot from your SEVIS record's CPT page. Once you proceed with the process on the next page (9) and meet with an OIES staff member, then you can return and upload the CPT screenshot. If you have never received CPT or OPT in the past, then no upload is necessary.

This is where you will upload a scanned copy of all your previous I-20s, including the new OPT I-20 that the OIES will give you during the advising appointment after you have uploaded the pdf of the draft I-765 available in the forms and guides section of the International Education and Services website.
