Relevant items from the previous report:

- 1. The QEP Website is restructured and updated.
 - a. Restructuring is completed. A QEP-Reports menu has been added for easy access to QEP Annual Reports and QEP Bi-weekly Progress Reports. The site is live now.
 - b. Links to Bi-weekly reports are available.
 - c. QEP Committee information as of January 31 2024, is updated.

- 2. QEP Information Session Meetings with Deans and Chairs are scheduled.
 - a. Two college meetings with chairs, COAS and COFAC, have been set up on 4/3. Also, COEHD and COE meetings are set up on 4/10 and 4/11 respectively.
 - b. A preparation is undergoing. We consider: One-page QEP information handout, the QEP comprehensive report (2023), Math Pathway flyers, and the current Declaration of Intent records for each college.

1. Monthly QEP Marketing and Outreach Committee meeting held on 3/20.

- A. Math Pathway information is shared and marketing items are discussed.
- B. Creating a new one-page flyer for HS counselors with endorsements are suggested. The committee set a tentative deadline for the new flyers on May 1st.

2. Monthly QEP Faculty and Student Support Committee meeting held on 3/25.

- A. A plan for continuous improvement effort on QEP math courses is outlined.
 - a. Run an item analysis on the exam on a regular course and identify one or two problem content areas.
 - b. Inform the problem areas to the instructors of the corresponding corequisite course. They perform appropriate changes/enforcement on these concepts.
 - c. Run an item analysis on the exam again to see any improvement on student performance. This feedback system ensures continuous improvement on student learning outcomes.

B. Brandy Palmer started a pilot project on MATH1332 by running an item analysis on her own exam dataset.
