#### I. Call to Order

#### III. Minutes

Megan Hale made a motion and Linda Turner seconded to accept the July 2011 minutes. The Senate unanimously approved the July 2011 minutes.

#### IV. Committee Reports

#### **Executive Committee:**

The Exec meeting with Dr. Simmons and Dr. Lassen was held on July 25, 2011. A question rose concerning the Early Childhood Center funding. And will the center be closing? Dr. Simmons and Dr. Lassen answered: Lamar will no longer be subsidizing the ECDC. It will remain open through August 31, 2012. The ECDC is not charged rent or utilities. Parents/employees will be given ample notice should the facility have to close after August 2012.

A question was asked if the Recreation Sports Center fee can be waived for employees. And can employees add a guest to their membership? Can guest passes or fees be offered? The answer: The fee will not be waived for employees. Everyone (students, faculty, and staff) have to pay to use the facility. We will need to speak with Norman Bellard in regards to guest/visitor passes. Another question was asked about how are other institutions in our system fairing with their funding during these hard times? The answer: The other institutions in our system have not gone through two devastating hurricanes and were able to build up substantial reserves. Lamar serves a "high-needs" student body (1<sup>st</sup> generation, low income, etc.). Sam Houston State University budget cut was 12%. However, their enrollment is much greater than Lamar. Lamar was cut 18%. Sul Ross is not doing well at all. Though not in our system, the University of Houston and Stephen F. Austin have furloughed employees – Lamar has not done this. Lamar will be asking the Board of Regents for tuition increase approval that will begin with the spring 2012 semester. If the entire increase is approved, it will cover the decrease in state funding.

A question concerning where are the Softball funds coming from was raised. The answer: This will be addressed at the next Staff Senate meeting. Dr. Lassen will speak to the senate. Due to Title IX, Lamar has to have a women's team to offset the men's football team.

A question was asked relating to the raised funds and what the funds are used for (The millions campaign). The answer: These are donor specific funds. They cannot be used for salaries. Facilities Management employees would like to have a meeting with Dr. Simmons and Dr. Lassen. They would like to have the opportunity to address issues and concerns with the executives. This has already taken place. Also, the working conditions of the "new" facilities location (the old motorcycle shop on MLK) are being addressed as well as the exterior look of the building.
